

Ainomo Cookies Policy

Introduction

This Cookies Policy explains how Ainomo ("we", "us", and "ours") use cookies and similar technologies to recognize you when you visit our websites at www.ainomo.com ("Website"). It explains what these technologies are and why we use them, as well as your rights to control our use of them.

What Are Cookies?

Cookies are small text files that are saved on your device (computer, tablet, or mobile phone) when you visit websites. They are designed to hold a modest amount of data specific to a particular client and website, and can be accessed either by the web server or the client's computer. This allows the server to deliver a page tailored to a particular user, or the page itself can contain some script that is aware of the data in the cookie and so is able to carry information from one visit to the website (or related site) to the next.

There are several types of cookies:

- **Session Cookies:** These are temporary cookies that expire once you close your browser. They're used to maintain functionality as you navigate through the site.
- **Persistent Cookies:** These remain on your device for a pre-specified period or until manually deleted. They're used to remember your preferences or actions across the site (or in some cases across different websites).
- **First-party Cookies:** Directly placed by the site you're visiting. They help the site remember information about your visit.
- **Third-party Cookies:** Placed by a domain other than the one you are visiting, often for tracking or advertising purposes.

Cookies can enhance your browsing experience by allowing websites to remember your actions and preferences (such as login and region selection). This means you don't have to re-enter this information each time you return to the site or browse from one page to another.

Why Do We Use Cookies?

Cookies serve a variety of functions on our website:

- **Essential Operations:** Some cookies are essential for the operation of our site. They manage session states, security, and enable basic functionality.
- **Performance and Analytics:** Cookies help us understand how our site is being used, how effective our marketing campaigns are, and help us customize and improve our websites for you. They collect information about which pages are most visited, how much time users spend there, and any issues encountered, like error messages.
- **Functionality:** These cookies remember choices you make such as the country you visit our website from, language, and search parameters. They make your visit more personal and less repetitive.

- **Advertising:** Cookies are used to deliver advertisements more relevant to you and your interests. They are also used to limit the number of times you see an advertisement as well as help measure the effectiveness of the advertising campaign.

Controlling Cookies

You have full control over the cookies stored on your device. Here's how you can manage your cookie preferences:

- **Browser Settings:** Most browsers allow you to see what cookies you have and delete them on an individual basis or block cookies from particular or all websites. Be aware that any preference you have set will be lost if you delete all cookies, including your preference to opt-out from cookies, as this itself requires an opt-out cookie to be set.
- **Third-party Management Tools:** Some third-party services offer management of cookies for you, including opting out of analytics and advertising cookies.
- **Direct Opt-Outs:** Websites often provide their own opt-out options for specific cookies. For instance, to opt-out of Google Analytics tracking across all websites, visit Google Analytics' opt-out page.
